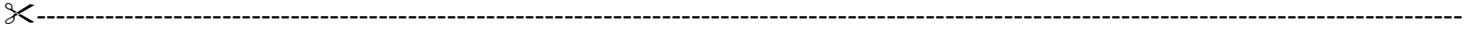

The Upstate Chapter invites you to join Wildlife Action, Inc. Wildlife Action is a Coalition that works for conservation, consisting of hunters, fishermen and environmentalists. The Upstate Chapter is managed by volunteers, some who are retired professionals, engineers, educators, and homemakers. Through its outreach to the Upstate community since 1991, the Upstate Chapter has taught over 20,000 children about wildlife conservation.

The facilities, known as the Hughston Resource Educational Center, are located at Lost Acres, 127 Halibut Lane, Spartanburg, SC 29303; north of I-85 and west of I-26. Weather permitting, Chapter meetings are held at the Foster Pavilion on the second Monday of each month. In addition, our members perform projects and programs to actively “give back more than we receive.” These include educational school programs and the annual Wild and Pioneer Days. As a member of Wildlife Action, you will receive the national Pride magazine and the Chapter monthly Newsletter containing details of meetings and upcoming events, as well as articles of interest to our members. We encourage you to become a Wildlife Action member and look forward to your active participation in our Chapter activities.

Membership dues are distributed 30% to the local chapter, 30% for state projects, and 40% for national projects and administration. 100% of funds raised by the Upstate Chapter stays with our chapter.
